Strategic Collaboration

GOLD CHILDCARE CENTER

Multiple organizations have been supporting, assisting, and advising Fadumo Ahmed as she has worked toward opening Gold Childcare Center, a culturally supportive child care center planned for East Grand Forks.

Fadumo, who had been providing in-home child care, set out to open a center as a solution to meet an increasing need in the community. She has seen Somali families struggle to find adequate child care due to language difficulties, cultural barriers, and insufficient flexibilities.

Integrity and Responsibility

RAPID RESPONSE FUNDING / CDFI

During COVID, the U.S. Department of Treasury created the Rapid Response program, open to certified CDFIs, including the Northwest Minnesota Foundation. NMF applied for and was awarded \$1 million in Rapid Response funds, to be expended over two years.

These funds provide exceptionally-low-interest loans to those from underrepresented communities and to business ventures in targeted geographic zones. George Coulombe, a land surveyor, was approved for a Rapid Response loan that allowed him to purchase his own equipment to grow his business, Coulombe Consulting.

George targets his work toward Native American reservations and smaller counties. Once on site, he works alongside local crews, teaching them skills that will benefit their local communities.

Community Revitalization

BUSINESS AND TECHNICAL ASSISTANCE

- Technical assistance = 1,480 hours of technical assistance provided to 86 borrowers
- Specialized services = Of those borrowers above, 35 received \$34,212 in technical assistance from specialized services

Commitment to Inclusion

RACIAL EQUITY ACCOUNTABILITY PROJECT

Sally Fineday is one of the members of the Racial Equity Accountability Project team, charged with examining and questioning the homeless response system with the goal of advancing racial equity and reducing racial disparities.

The Northwest Minnesota REAP team is part of a statewide initiative aimed at addressing inadequacies in the statewide homeless response system. Data from that system shows that, in Minnesota, people of color experience homelessness and housing instability at rates that are 7 to 8 times higher than their representation within the general population.

Boldly Making a Difference

IMPACT FOR TOMORROW

With the goal of making a meaningful, lasting impact on the Park Rapids and Nevis area, Mark and Peggy Hewitt worked with the Northwest Minnesota Foundation to hold an open grant round for nonprofits that are working to remove barriers for youth and families to achieve success.

The Hewitt Family Charitable Fund has granted \$240,000 since its inception in 2000, but the open grant round that was held last fall allowed the couple to truly target their giving in a powerful way, issuing \$83,000 in grants to seven nonprofits in Park Rapids and Nevis.
